Health Financial Systems licenses its software to a company. The license is not transferable. This license extends to all physical locations of that company. The HFS standard yearly license fee grants the user the right to file one Medicare cost report or one LTCIR report or one CHDR report or one IRIS report. An additional license fee must be paid to HFS for each additional Medicare cost report or other report filed using the HFS software.

HFS will not charge additional license fees for low utilization cost reports, no utilization cost reports, or multiple Medicare cost reports filed for the same provider during the same cost report period (aka short period cost reports). Nor is an additional license required to file a Medicaid report with a state agency that is filed for the same provider and the same cost report period as the Medicare cost report for which a license has been obtained. Health Financial Systems has the right to collect cost report submission data for administration purposes. Entities without a license wishing to use the cost report software for review only purposes may obtain a review license, but no cost reports may be filed pursuant to the review license.

Notable changes in the HFS licensing as of 1/1/2017:

- Companies will not be charged additional location fees.
- HFS now offers a review license that can be purchased for a discounted price. This review license will allow users to have full use of the HFS software but will NOT entitle the user to file a cost report.
- Unlimited use licenses have been removed from our price list. Due to the number of mergers and outsourced reports this licensing option has been removed as a purchase option. HFS will contact and work with our existing unlimited use clients to ease this transition.
