### Patch Notes

#### **Interface, MCRIF32, version 1.60.0.1**

Other - Corrected an issue entering data in various .mcx worksheets, switching between worksheets and tabs while entering data caused the HFS software to stop working. (D001-00-015068)

#### **Hospital, 2552-10, version 10.4.160.1**

Batch Data Extractor - Corrected an issue where the extractor stopped when an invalid worksheet entry is found in the csdx file. (D001-00-015003)

Data Entry - Corrected data entry on Worksheet S-2, Part I line 109 columns 1 through 4 where we were not placing the entry as Capital Letter and not center alignment. (D001-00-015097)

Edits - Corrected edit 20460S that was triggered when Worksheet S-2, Part I, line 65, column 1, is blank. (D001-00-015057)

#### **HHA, 1728-94, version 17.3.160.2**

AAI - Corrected an issue with the account descriptions not displaying at the bottom of the AAI screen when viewing a workbook's account numbers. (D001-00-014987)

Data Entry - Corrected an issue with using the Template feature in creating a new mcx file where the County was not being brought over from the prior year file to Worksheet S-3. (D001-00-014988)

Printouts - Corrected the printout of Worksheet S-3, where the lines 11 through 29.XX columns were shifted to the right so the last column was missing from the sheet.

The system was updated to maintain compatibility with the Interface.
