2552-10 T5 and Other Software Update Notification

Dear Clients:

The main reason for this software update is to incorporate the 2552-10 T5 changes.

All software was updated to remain compatible and fix miscellaneous issues detailed below.

Hospital Transmittal #5

HFS was approved by CMS for Transmittal 5 on 3/31/2014. This transmittal has an effective date of cost reporting periods overlapping or beginning on or after October 1, 2013. The major T-5 changes include:

- Incorporation of changes for the Model 4 bundled payments for care improvement (BPCI) initiative but paid outside of the bundled payment in accordance with ACA 2010, Section 3023, effective for services on or after October 1, 2013.
- Updates for changes to Inpatient Rehabilitation payment adjustments for the low income patient (LIP) and update of the teaching adjustment factor effective for services on or after October 1, 2013.
- FFY 2014 IPPS changes to include Medicare labor and delivery days in the calculation of the Medicare patient load ratio used to apportion direct graduate medical education payments in accordance with the IPPS final rule effective for cost reporting periods beginning on or after October 1, 2013.
- Implement of the calculation of Uncompensated Care Payments effective for services on or after October 1, 2013.

Revisions:

- Worksheet A:
 - Corrected instructions for lines 71 and 72, medical supplies charged to patients and implantable devices charged to patients, respectively.
- Worksheet E, Part B:
 - Added line 39.98 to reflect partial or full credits received from manufacturers for replaced devices.
- Modified or added instructions to implement section 3023 of the Affordable Care Act of 2010 as follows:
 - Worksheet E, Part A:
 - Added lines 1.03 and 2.02, and revised lines 22, 28, 34, 47, 62 and 63 for Model 4 bundled payments for care improvement (BPCI) initiative.

 - Added lines 1.01 and 2.01, and revised the instructions for lines 6, 11 and 12 for Model 4 BPCI initiative.

 - Revised instructions for lines 26 and 27 for the Medicare patient load ratio.

 - Worksheet E-3, Part III:
 - Revised the instructions for lines 1 and 3 for the inpatient rehabilitation facility low income patient adjustment factor and lines 11 through 13 for the teaching adjustment factor.
