339 - Corrected the title on the 339, Exhibit 2 for IP and OP, to correctly read "Indigency & Medicaid Beneficiary." (D001-00-013376)

Auditor - Corrected an issue where adjustments made to Worksheet E Part A, line 8.01 and Worksheet E-4, line 4.01 were not being applied. (D001-00-013429)

Calculate - Fixed the calculation of Worksheet E Part A lines 100 - 104 column 2 for MDH providers that are partial year MDH. (D001-00-013437)

Calculate - Corrected an issue with the calculation of the Worksheet E, Part A, Exhibit 4, for MDH providers. (D001-00-013457)

Calculate - Fixed an issue where we were not bringing in the Low Volume Factor on Worksheet E Part A Exhibit 4 line 27 column 4. (D001-00-013458)
