We recently updated the software for the Interface, Hospital, SNF, HHA, CORF/CMHC, HO, Hospice, RHC, ESRD, CHDR, LTCIR and OPO systems.

Interface, MCRIF32, version 1.52.0.0

Edits - Added new verbiage for warning edits when a positive adjustment is found on W/S A-8 (or equivalent worksheet). We added "Verify the amount should be negative." (D001-00-008901)

PS&R - Modified the PS&R CSV import to recognize the new column data that has been added by CMS for DSH Uncompensated Care. (D001-00-008984)

Hospital, 2552-10, version 4.8.152.0

Calculations - Corrected the calculation of W/S I-5 column 2 when the facility composite rate is 1.0. In this case, column 2 should equal column 1. Also fixed an issue with I-5 line 5.04 col 2 where we were not calculating this properly when line 14 was not equal to 1.000. (D001-00-008974)

Calculations - Modified the transfer of Worksheet A Salaries with cost center codes of 01890-01899 to Worksheet S-3, Part II. This affects New York providers only. (D001-00-009018)

Calculations - Corrected the calculation W/S E-1, Part II line 32. (D001-00-009019)

Calculations - Modified the TOPPS calculation to properly handle the TOPPS expiration date when the provider is an SCH. (D001-00-009048)

ECR Import - Modified how overflow days are handled during ECR Import for older files. Files with a vendor approval code of 'A' or 'B' that have overflow days on W/S D-1 that match the days on W/S S-3 will have these days zeroed as they were probably written to the ECR file incorrectly during the 'A' and 'B' time period. Edits - Corrected issuing erroneous Serious edits for missing W/S D series for titles V & XIX when these titles are not applicable for the report. (D001-00-007987)

Edits - Updated Serious edit 710 for CMS 2014 rural/urban rates for RHC and FQHC. (D001-00-009014)

Edits - Corrected Serious edit 108 on W/S S-7 to check for a certified SNF rather than a Swing-bed SNF on S-2. (D001-00-009054)



Printing - Corrected printing of W/S A-8-1, which sometimes caused the system to lock up. (D001-00-009042)

Management Reports - Added enhanced menu file conversion when an updated menu is required to run Management Reports. This was added to prevent outdated menu files from running with the software, which caused unpredictable report results. (D001-00-009007)

Management Reports - Modified the W/S A-4 comparison report to compare lines 1 through 10, column 6. (D001-00-008948)
