The HFS/Toyon HCRIS website has been updated with the 1st Quarter data released by CMS on 4/201/2015. 3,320 2552-10 and 1,247 2552-96 reports were added. The site has processed this data and it can be viewed in the Snap Shot Reports, extracted through the Advanced Search and Extract and the .mcrx and .pdf reports (for 2552-10 reports only) have been made available.
