Dear HFS IRIS Clients:

We recently posted a new update for the IRIS SQL system. The changes are summarized below.


IRIS, version 5.0.3.05:

- D11115 IRIS Added scripts to display added providers in all reports. Also added scripts for those who have already added providers and need them to show.
- D11116 IRIS Made the fields on the Intern Assignment Info screen more visible.
- D11125 IRIS Corrected the Master Variance Report by adding a date conversion for both med grad fields to compare was previously erroneously identifying variance when dates were the same.
- D11146 IRIS Changed the Preference defaults for new installs to make Import Partial as False and Input Assistance to True. Also corrected the GME-P on detail assignments to include OB/GYN as cost report includes FTEs together.
- D11147 IRIS Corrected some Imported Master Variance report fields used in the query for the report.
- D11155 IRIS Revised the header in the Audit Report FTE by residency code summary page, was Interns but should have been assignments.
- D11186 IRIS Updated the OIG Report screen to display the latest download date field. Also added code to include the field in the report.
- D11268 IRIS Corrected the FTE calculation for IME when the cost reporting period is a short period report. We were computing it based on 365 (or 366) rather than based on # of days in cost reporting period.
- D11269 IRIS Added a check box to ignore variances of 30 days or less in the med grad date and foreign cert date when running the Imported Master Variance Report.
- D11270 IRIS Corrected the Duplicate Checker to properly identify possible duplicate interns, where the resident's last name is same but SSN is off a bit.
- D11289 IRIS Corrected an issue with the Yrs Complete and Yrs Comp Wght warnings that were not working on FMG residents.
- D11295 IRIS On the Legacy Access Import, updated the get function to blank those comment fields out when it's a 1/1/1900. Apparently, when importing access it defaulted to this date. We've also updated the functionality to blank them out upon importing if it's 1/1/1900.
- D11386 IRIS Fixed an issue where we were not saving a change to the M portion (upper portion) of the residency info screen for the Residency Code, it says it was saved but did not.
- D11387 IRIS Fixed an issue with importing of M & A records when they were having inconsistent file name (the M & A were not both upper and lower case).



- D11400 IRIS Included messages if user does not have access to delete or edit. This is a feature mainly used by MACs.
- D11407 IRIS Corrected an issue where changes made to the Assignment Time % was not being retained.

You will need to go to our website www.hfssoft.com and go to the download page. You may be asked to log in. You will want to select the IRIS link to download. If you have already installed the IRIS software, when you retrieve the download, you will see the following inside the zipped file (ignore the dates below); you will only need to run the HFSIRIS.msi. If you have not installed the system yet, then run the setup.exe.



We are working on updating the system to retrieve updates directly thru the system using Help – Check for Updates like we have in the cost reporting software.
