We recently released a software update for the Interface, Hospital, SNF, ESRD, HHA, RHC, Hospice, CORF/CMHC, CHDR, LTCIR and OPO systems. The primary reason for this patch is to repair software issues.

Interface, MCRIF32, version 1.58.0.3

Auditor - Auditor will default to the next available Worksheet A-6 reclassification code or Worksheet A-8 line. (D001-00-011157)

Other - Corrected an issue with the submission of data through the Task Pane Submit Feedback option. (D001-00-011397)

PS&R - Updated the PS&R Reconciliation to accept the revised CMS csv files that include the "Pioneer Reduction" field along with the change from "Gross APC Payment" to "Gross APC/PPS Payments". (D001-00-011725)

AAI - We fixed the ability to use the Statistics for the AAI feature allowing the user to split amounts between cost centers. (D001-00-011345)
