We recently updated the software for the Hospital, SNF and ESRD systems.

## Hospital, 2552-10, version 4.7.151.0

Auditor - Corrected issue with the display of Totals for reclassifications added through Auditor. (D001-00-008973)

Auditor - Fixed an issue where Auditor was not allowing negative numbers to be "added" to W/S S-3, Part, columns 9 and 10 adjustments. (D001-00-008981)

Calculations - Modified the transfer of W/S B, Part I line with cost center code of 01852 to I-1 line 26. This affects New York providers only. (D001-00-008971)

Calculations - Corrected the calculation of W/S I-5 column 2 when the facility composite rate is 1.0. In this case, column 2 should equal column 1. (D001-00-008974)

Edits - Serious edit 60200S - code 74 not recognizing WI in J6. This is fixed. (D001-00-008959)

Printouts - Corrected the printing of W/S A-8-1. In some files that have many subscripted lines on A-8-1, the worksheet would freeze during printing. (D001-00-007805)

PS&R - Corrected the reverse adjustment for W/S S-7 swing - bed SNF when the provider files an amount on S-7 but PS&R has zero. (D001-00-008969)

PS&R - Corrected a PS&R import issue with multiple ESRD csv files, we are now properly importing all csv files under the 1st ESRD provider number listed on W/S S-2 Pt I line 18. (D001-00-008991)

Special Reports - Updated the SR916 OPPS CCR report to incorporate the CMS statewide averages from the CMS table effective 1-1-14. (D001-00-008985)

Worksheets - Corrected misspelling on W/S S "falure" instead of "failure". (D001-00-008990)

PS&R - Corrected the reverse adjustment for W/S S-7 swing - bed SNF when the provider files an amount on S-7 but PS&R has zero. (D001-00-008968)

ECR Export - Corrected exporting of W/S A-8-1, Part II line 10 subscripts to the ECR file. (D001-00-008989)

Edits - Removed edit 6000A to be issued against cost center lines that do not contain any input data on A and B-1. (D001-00-008955)

Edits - Software was generating Level I edit 1000S and HCRIS Consistency edit for missing street address. CMS clarified that street address not required if PO Box present, and vice versa. This is fixed. (D001-00-008972)
