Update Notes

Hospital, 2552-10, version 11.4.164.0

Calculate - Corrected Low Volume calculation for SCH providers where line 14 is greater than line 13, then line 15 will be line 14 plus line 9.01. (D001-00-016687)

Calculate - Corrected an issue with Worksheet E, Part A, line 47, for a SCH provider with a mid year (non 10-1) geographic reclassification. (D001-00-016747)

Calculate - Corrected a rounding issue with Worksheet D-1, line 25, which caused a settlement difference for observation bed day cost computation. (D001-00-016817)

Calculate - Corrected the direct flow for Worksheet E-3, Part IV, line 50, to come from line 2. (D001-00-016848)

Data Entry - Added automatic Stat Code of T (Gross Patient Days). When a T is used as a Stat Code, it will auto-populate the line 30 Statistic from Worksheet S-3, Part I, column 8, Line 7. This differs from Stat Code P (Total Patients Days) that auto-populates the line 30 Statistic from Worksheet S-3, Part I, column 8, Line 1. (D001-00-016820)

ECR Export - We will no longer export Worksheet S-8, line 15, all columns, for reports ending on or after October 1, 2014 for hdt and ECR files. (D001-00-016698)

ECR Import - Corrected a rounding issue with Worksheet A-8-3, line 48, on ECR import that was corrected on calculation. (D001-00-016807)

Edits - Revised application of edit 10000S to allow providers to report a DSH payment percentage on Worksheet E, Part A, even though a provider may not have qualified for DSH payment (line 34 will calculate as -0-). This change conforms to the current CMS specifications. (D001-00-016777)

Management Reports - Modified report 57 so that the days to days ratio is applied to all applicable detail lines of A-6 reclasses, instead of applying the ratio only to the total amount of each reclassification. (D001-00-016767)

PS&R - Changed the import of PS&R report 11A ACP (Actual Claims Payment for PIP) field to now identify it with the Report 11A (was previously included with the 110). This is only for PIP providers, the 11A report is ignored for non-PIP providers. (D001-00-016657)

PS&R - Created an assignment for PS&R Report 11A, ACP (Actual Claim Payments for PIP) to Worksheet E-1, Part I, line 1, column 2. This was previously included with report 110. (D001-00-016837)
