We recently updated the software for the Interface, Hospital, SNF, ESRD, HHA, RHC, Hospice, HO, CORF/CMHC, OPO, CHDR and LTCIR systems. The primary reason for this update is to implement CMS changes, repair software issues, and implement additional features.

### **Interface, MCRIF32, version 1.55.0.0**

Forms - Modified the system to allow the Edits Listing Form to be moved to a separate monitor when more than one monitor is active. This allows interaction with the worksheets while still being able to view the edits. (D001-00-008796)

Batch Data Extractor - Added an option to extract data from adjusted cost report files (MCAX). (D001-00-009367)
