Dear Clients:

We recently updated the software for the Interface, Hospital, SNF, RHC, ESRD, HHA, and Hospice systems. The primary reason for this update is to implement CMS changes, repair software issues, and implement additional features.

Interface, MCRIF32, version 1.31.0.3:

PI Viewer - When viewing a PI file in PDF format we now extract the Fingerprint and display it in the PI Viewer top bar (upper left) at all times. D#2862

Hospital, 2552-10, version 2.32.131.0

Add/Delete Cost Centers- There was no way to add lines 99.20 - 99.49 (OPT, OOT, OSP) on the Cost Center and Statistic Setup screen. We added these options on our cost center screen, for line 99. D#5081

Auditor - When we are applying audit adjustments, the printout is not identifying the line and column descriptions like we had in the 2552-96 printouts. For example, for I/P ancillary charge adjustment, the 2552-96 would show it as D-4, Title XVIII, Hospital, Line 30.00 OPERATING ROOM and for the column we would show 2.00 INPATIENT PROGRAM CHARGES. In the 2552-10 we are showing it as D-3, Title XVIII, Hospital, Line 50.00 (not showing the cost center description) and the column is just showing 2.00 (again no description). This is happening throughout the auditor printout - it is working with E-2, E-3 part V, M-3 lines 23 & 24 but not line 10 nor 18. This is fixed. D#4966

ECR Export- we added W/S B Part II, line 92.01 through 92.10, to our ECR specification. These lines were missing, and therefore, not exporting to the ECR file. D#4936

Edits- edit 10900 was issuing improperly for W/S A-8-1, line 5, column 5. If you look at the screen it is - 8,429,318 but the edit listing is showing it as -8429318.000000. We modified the display precision for this data. D#4969

Edits- we added HFS edit 60250S to check for a provider number related to the worksheet being used. If a provider number is not entered on Worksheet S-2 part I, for a particular worksheet, we will issue edit 60250S and prevent the creation of an ECR file. D#4987

Edits - we modified Level I edit 10655 logic to catch "other" cost centers (i.e. line 18.xx) with invalid codes. Valid range is 01850 to 01899. There is an exception for NY providers. D#4930

Edits- we modified Level I edit 10655 to exempt NY providers from certain cost center codes. D#4959

Edits- We were issuing 10450S in error. If S-2 part I, line 63 = Y, and line 66 is blank, but line 67 has data, we were not recognizing line 67 column 1 "alpha data" as passing 10450S. We modified the 10450S logic to accept line 67 data as Alpha or Numeric. D#4967

Worksheets- Corrected the subscripting of column 1 on Worksheet E part B. We were incorrectly subscripting the column when a Sole Community Hospital fiscal year overlapped 1/1/2012. D#5026

Hospital, 2552-96, version 25.26.131.0:

Screen/Display - we corrected a display problem on W/S E-3 part IV, line 3.22, where it was displaying as a decimal (dollars and cents) field, instead of whole dollars. Printouts and calculations were correct. This is fixed. D#5090

SNF, 2540-10, version 3.14.131.0:

Auditor- We corrected an issue where the line and column descriptions were not being identified in the Adjustment Report. D#5031

Calculate- We have added edits to be generated if the HCRIS codes are not valid for a cost center. D#4931

Data Entry- We have added an HFS 6000 series Level I edit if the Contractor number entered on S-2, I, line 45.00, col. 3.00, is not numeric. D#4810

Edits- Added a HCRIS serious edit if D-1 Pt II line 3 > 0 then S-2 Pt II line 6 or 7 must be Y and vice versa. D#5018



Edits- Per CMS directive, we have reverted 1045S back to T.3. We had 1045S programmed for T.4 changes that have not been finalized. D#5068
