We recently updated the software for the Interface, Hospital, SNF, ESRD, HHA, HO, RHC, Hospice, CORF/CMHC, OPO, CHDR and LTCIR systems. The primary reason for this update is to implement CMS changes, repair software issues, and implement additional features.

## **Interface, MCRIF32, version 1.43.0.0**

Printing - Corrected an error that occurred when printing files from two different cost report form sets. (D001-00-007936)

Auditor - Added W/S E-1, Part II to the list of worksheets in Auditor that can be adjusted. D.001-00-007856 (D001-00-007856)

ECR Import - Modified ECR Import to automatically add cost centers on W/S A, that are related to components on W/S S-2, Part I, when these components are present in the ECR file but the cost centers are not present. (D001-00-007855)

ECR Import - Added line 100 to Exhibit 4 to signal when the user wants to transfer the low volume adjustments to E, Part A. During ECR Import, line 100 will be forced to N. When Exhibit 4 line 100 is N, this overrides any decision to transfer from Exhibit 4. We will not transfer Exhibit 4 to E, Part A if line 100 has a value of N. (D001-00-007935)
