Dear Clients:

We recently updated the software for the Interface, Hospital, SNF, Hospice, ESRD, and WinHTF systems. The primary reason for this update is to implement CMS changes, repair software issues, and implement additional features.

SNF, 2540-10, version 3.9.130.0:

D#4121- Calculate- We changed the calculation of D-1 T19 to be based upon S-2 Pt I line 37 - if Y, then D-1 T19 line 1 should be S-3 Pt I col 7 lines 1 + 2; D-1 T19 line 3 should be S-3 Pt I col 5 lines 1 + 2 and D-1 T19 line 5 should be from B Pt I col 18 lines 30 + 31. The D-1 T19 amounts will then transfer to E Pt II NF worksheet.

D#4489- Data Extractor- Corrected an issue with Data Extractor where "GHOST" amounts from deleted lines were being incorrectly extracted.

SNF, 2540-96, version 18.21.130.0:

D#4212- Edits- We corrected an issue with a HCRIS consistency edit (2050) that was referencing S-2 instead of the FI worksheet S screen.

Hospital, 2552-10, version 2.27.130.0:

D#4172- Management Report- Improved Statistic and Cost Center Headings

D#4173- Management Reports- Improved print format to fit all columns on one page.

D#4413- Data Extractor- Correct an issue in Data Extractor where "ghost" amounts from deleted cost centers were being included in the extract.

D#4478- Data Entry- We have opened H-2, Part I Column 25 PSA for input.

D#4479- Edits- Added an HFS Level I edit 60000D ifD-1, line 7 zero and if line 8 is zero and S-3 days are greater than zero.

D#4480- Edits- Added an HFS Level I edit 60175S, if S-2, I line 105 (CAH) is Yes and S-2, I, lines 3 and 7, col. 7.00 is NOT "O".

D#4546- Edits- Removed line 58.00 needing a response from Level 1 edit 10450S.



D#4547- Edits- Downgraded Level I edit 13400S to a Level II for a CAH as S-7 should NOT apply to CAH as they are reimbursed on cost and not by RUGs.

D#4559- Edits - we modified the logic for Level I edit 10350E to not issue erroneously, when a teaching program was in the third year.

D#4568- Calculate- Corrected the transfers from Worksheet C to B-1 when using the automated statistics. We were incorrectly transferring line 61 to B-1 and including that value in the UCM calculation.

Hospital, 2552-96, version 25.21.130.0:

D#4446- Edits- We corrected an issue where HFS edit 6015I was NOT being generated if I-1, line 27 is negative.

ESRD, 265-11, version 1.13.130.0:

D#4378 & D#4457- Printouts- We corrected the printing of extraneous data (zero values) for the Reclassification worksheet. This fixed has been made on the 265-11, 2540-10, and 2552-10 formsets.

D#4488- Data Entry- Added line 11 to S worksheet and included this field in the ECR export file.

D#4490- Data Entry- Corrected an issue with Data Extractor where "GHOST" amounts from deleted lines were being incorrectly extracted.

D#4567- Edits- Downgraded Level I 6050E to a serious and reworded: Serious - W/S E part I, line 8 should not be used for cost reporting periods Beginning on or after 1/1/2011, unless this line 8 bad debt relates to services prior to 1/1/2011 and is being written off. Use line 12 for bad debts on or after 1/1/2011.

Hospice, 1984-99, version 9.7.130.0:

D#4548- ECR Import- We corrected an issue where we were not populating S, lines 4 and 5 when importing an Optimizer EC file. This in turn was not answering question 1 on the Acceptability Checklist which has now also been corrected.

WinHTF, version 3.1.0.0

D#4566- Problems- Contractor/FI - WinHTF was updated for recent HCRIS changes in the format of the Contractor number, from numeric data to alphanumeric data, in the HDT file.
