Interface, MCRIF32, version 1.59.0.17

PS&R - Corrected an access violation error which would occur when you are in PS&R Reconciliation Tool and then open up Medicare Auditor and export PS&R adjustments to Auditor. (D001-00-014708)

Recent File - If an MCR or MCRX file has been moved or deleted, but it was a file recently opened. It will appear as gray or in red text when looking in File | Recent Files or the Task Pane. (D001-00-014646)

Wage Index Lookup - Updated the data for the Wage Index Lookup tool to incorporate the changes effective 10-1-2016. (D001-00-014557)

Calculate - Corrected an issue with the subscripting of Worksheet S-5, line 23, where line 10.01 is "Y" and there is more than one ESRD unit reported on Worksheet S-2, line 18. (D001-00-014809)
