We recently updated the software for the Interface, Hospital, SNF, ESRD, HHA, RHC, Hospice, CORF/CHMC, CHDR, LTCIR, HO, and OPO systems. The primary reason for this update is to implement CMS changes, repair software issues, and implement additional features.

**Interface, MCRIF32, version 1.39.0.0:**

Web Site - The User Manual under Support, Knowledge Base Search, Help, on our Website was v1.4, it has been updated to the latest version 3.0. (D001-00-007143)

**Hospital, 2552-10, version 3.8.139.0:**

Calculate - We modified calculate for New York providers allocating A&G last, as cost centers 23.51-23.56, while the cost centers are appropriately recognized as A&G on Worksheet B, Part I, they were being treated as para-medical cost centers for Worksheet B, Part II. This is fixed. (D001-00-007041)

ECR Export - We modified ECR Export to include two MDH periods, W/S S-2 part I, lines 38.00 and 38.01. Line 38.01 was not written out to the ECR file (this also happened with SCH lines 36.00 and 36.01). We now write out all line 36 & 38 subscripts, as there also could be more subscripts. (D001-00-007057)

HELP - We modified Help (CMS Instructions) to add HFS notes (e.g. S-2 part I, line 118.01), and to incorporate CMS clarifications. (D001-00-007203)

Management Reports - Corrected printing of the report from the File | Print menu. (D001-00-006994)

Management Reports - Corrected the reporting of values on Report #63, A-8-2, in order to properly match adjustment comparisons to A-8. (D001-00-007001)

Management Reports - Management Report #63 (A-8), the tolerance criteria is on the screen, however, when you do a print preview or print, the amounts of the criteria are not displayed. This is fixed. (D001-00-007051)

PS&R - Added PS&R assignment for the new fields VBP (Value Based Purchasing) to E Part A line 70.93 and HRR (Hospital Readmission Reduction) to E Part A line 70.94. (D001-00-007142)

PS&R - Changed the assignment for Days (DCRU) for 11S PS&R reports from line 1 to stat code DAYS to pick up any days associated with special care units. (D001-00-007145)



## **Hospital, 2552-96, version 25.43.139.0:**

Auditor - We modified Auditor to accept adjustments to D part V line 65.01, Ambulance, for FY Beginning prior to 1/1/2006. For FYB 1/1/2006 and after, line 65.01 is N/A. (D001-00-006986)

Auditor - We have fixed the Overlay function in the Move/Change/Combine feature in Auditor. (D001-00-007075)

DSH Worksheet - We modified the logic for the DSH calculation worksheet for E part A. We modified the logic for the 12% cap for Rural, less than 500 bed providers. We also modified the display of percentages to display as 12.00% instead of 0.12. We added a line 18.01 for Observation Beds, which are subtracted for line 19. There were other miscellaneous changes. (D001-00-006984)

Auditor - We have fixed the Overlay function in the Move/Change/Combine feature in Auditor. (D001-00-007035)

ECR Export - Worksheet S-2 part I, line 15, column 2 did not export. This is fixed. (D001-00-007147)

HCRIS - We modified HCRIS edit S020 for W/S S-2, part I, line 4, to NOT check "column 5 AND 6" as the edit is only for "column 5 AND/OR 6". This is fixed. (D001-00-007073)

Management Reports - Added Single Year report #90 to Management Reports. (D001-00-006831)

Management Reports - Added report #51 for Worksheet A to the Management Reports feature. (D001-00-6835)

**ESRD, 265-11, version 1.33.139.0:**

Edits - We added HCRIS Consistency Edit #111, for missing or invalid date on S-2 lines 2, 4, 9, and 10. The ECR file had 00/03/2012, which we did not import, but then HCRIS rejected for the missing date. This is fixed. (D001-00-007044)

Edits - We added an HFS Level I edit, 6000F, for missing worksheet F's. If Worksheet F, any line is not greater than zero, issue HFS Level I error. This includes if Worksheet F is not "open". Similarly, If Worksheet F-1, any line is not greater than zero, issue HFS Level I error. This includes if Worksheet F-1 is not "open". The F worksheets are required by CMS. (D001-00-007148)

The system was updated to maintain compatibility with the Interface.

**HHA, 1728-94, version 15.36.139.0:**

The system was updated to maintain compatibility with the Interface.

**RHC, 222-92, version 10.31.139.0:**

P&SR/Auditor - Corrected the assignment of the FQHC/RHC PS&R amounts of the first provider when it is a consolidated provider. We had an issue with the first provider with reports 770 & 77S. (D001-00-007091)

**Hospice, 1984-99, version 9.23.139.0:**

The system was updated to maintain compatibility with the Interface.
