Dear Clients:

We recently released a software update for the Interface, Hospital, SNF, ESRD, RHC, FQHC, Hospice, HHA, HO, CORF, and OPO systems. The primary reason for this update is to implement CMS changes, repair software issues, and implement additional features.

CMS has implemented an IRIS database in STAR (System for Tracking Audit and Reimbursement) and MACs are beginning to import the provider's M & A dbf files and STAR will be computing FTE counts to compare to the Medicare Cost Report. To address this potential change, we have implemented a Special Report (SR923) into the HFS cost report software. In addition we have implemented Level II edits that you will begin to see on Teaching Facility cost reports.
