## **Interface, MCRIF32, version 1.52.0.1**

API Excel - The spreadsheet can extract data from column 0. (D001-00-008889)

Auditor - Added the ability to print all Auditor reports to a single PDF file. (D001-00-006813)

Printing - Corrected the saving of the PDF file output location when using Batch Printing. (D001-00-009040)

API - Modified the API result stream to exclude the leading space from the time stamp. (D001-00-009076)
