Website Update - New Customer Portal

We have added a Customer Portal to our website. The portal can be accessed by any client who has a user name and password. If you do not have one, email us and we can set one up for you.

The Customer Portal tab includes:

General Information - your Company's name, address, email, and phone and fax numbers.

License Information - which products you currently have, the billing month and the number of reports we have you as filing.

Users Information - shows each active person on your account, their email address, phone number and who the primary contact for the account is. Also, in this tab HCRIS users are also listed, since this database is charge on the number of users.

Ticket Information - shows any tickets you have submitted to HFS, the date/time they were submitted and the status of your tickets.

Update Account - here you can edit your company's address, update the number of reports you are filing, and edit user information for your account.
