We recently released a software update. This update contains two CMS Transmittal changes:

- The RHC/FQHC, 222-92 system was updated to Transmittal 12 by CMS. Transmittal 12 is effective for cost reporting periods beginning on or after October 1, 2014. The primary purpose for this transmittal was to implement edits prohibiting the use of Form 222-92 by FQHCs, for cost reporting periods beginning on or after October 1, 2014.
- The Hospital 2552-10 system was updated to Transmittal 8 by CMS. Transmittal 8 is effective for
 cost reporting periods beginning on or after October 1, 2014. The primary purpose for this
 transmittal was to implement Federal Fiscal Year 2016 Inpatient PPS provisions.
