Today's software update repairs some issues in our systems, adds some enhancements and updates all systems to the latest versions. **HFS received approval for 2540-10 Transmittal #7 on 10/24/2016.** 2540-10 Transmittal #7 is effective for FYB 10/1/2015 and it is necessary to incorporate §3132 of the Patient Protection and Affordable Care Act (ACA) which require that CMS collect appropriate data and information to facilitate hospice payment reform. The O series has been added to replace the K series and S-8 has been modified. The S-5 and I series instructions have also been modified.
