Interface, MCRIF32, version 1.59.0.8

API Excel Spreadsheet - Corrected issue with extracts of both Worksheet B, Part I, columns 24 and 25 impacting line 202. (D001-00-012661)

Other - When creating the ECR and storing on SaFE, 'user name' was corrected to display as one word- 'username'. (D001-00-013587)

PS&R - Updated the PS&R csv import to account for CMS adding 6 new fields to the PS&R summary reports. (D001-00-013688)

Hospital, 2552-10, version 9.4.159.0

Edits - Corrected issue with serious edit 723 for Worksheet E, Part A, line 33, column 1, which was erroneously evaluating the value on line 33, column 1.01, instead of column 1. (D001-00-013377)

Edits - Added a level II edit when Worksheet S-2, line 40, is Y/Y saying Worksheet E, part A, line 70.99, should be greater than -0-. By adding a 'Y' to Worksheet E, Part A, Exhibit 5, line 100 the HAC adjustment amount will be transferred over to Worksheet E, part A line 70.99. (D001-00-013719)

Printouts - Star edits will now print when edits are printed or saved as a PDF. (D001-00-013720)

PS&R - Corrected an issue with the PS&R reverse adjustment for Medicare HMO visits were not being made when the PS&R report 118 was not imported. (D001-00-013536)

Edits - Corrected issue with edit 1015B flagging when not appropriate. (D001-00-013626)

Auditor - Corrected issues with the Auditor feature. Auditor was not correctly displaying some original cell values for worksheet B parts I & II. Also corrected an issue where the cell being adjusted did not immediately turn the font color gray letting the user know there is an unapplied adjustment for that cell. (D001-00-013716)

Auditor - Corrected issue with display after application of audit adjustments. (D001-00-013769)

Edits - Clarified description of edit 61080 to state that the line description is invalid and cannot contain "(Specify)". (D001-00-013616)

Edits - Corrected issue with level I edit 1430S being triggered when there was a value on Worksheet A-2-1, line 4, column 4 but not line 4, column 5. Edit should only be triggered when both values are missing. (D001-00-013706)

Printouts - Corrected issue with printing of edits from View Edits. (D001-00-013646)

Edits - Corrected problem with warning edit 4 which should have been, but was not triggered on Page 0, lines 6 & 7 when the input did not match the required format. (D001-00-013609)
