Dear Clients:

We recently updated the software for the Interface, Hospital, SNF, ESRD, RHC/FQHC, CORF/CMHC, HHA, Hospice and CHDR systems. The primary reason for this update is to implement CMS changes, repair software issues, and implement additional features.

Interface, MCRIF32, version 1.31.0.7:

Batch Acceptance - This is the addition of the "Select all providers" printing option in the Batch Acceptance print screen (under File - Print). (D#001-00-000932)

Printouts - Improved the speed of printouts. (D#001-00-005472)

Hospital, 2552-10, version 2.36.131.0:

Auditor - Corrected the freezing of printing the Auditor Adjustment Report when the combination of the cover page and the page numbers included options were used. (D#001-00-005493)

Batch ECR Import - Modified the way we make available optional reports to be printed during Batch ECR Import. (D#001-00-005404)

Calculate - Modified logic related to analysis of A&G cost center lines. (D#001-00-005456)

Calculate - Corrected the calculation of Worksheet C, Part II, line 200, column 7, and the correct total now is being displayed. (D#001-00-005484)

Calculate - Corrected calculations between Worksheet E-1 part I and E part B. We were automatically opening E part B for the SNF component when there were no Part B interim payments. (D#001-00-005491)

Calculate - Modified the calculation of Worksheet E, Part A line 47 by adding in line 2.01 to the calculation in accordance with CMS clarification. (D001-00-005552)

Data Entry - If an A-6 reclassification is "out-of-balance", then the "out-of-balance" total column header will be displayed in Red. (D#001-00-005379)

Edits - Modified some Contractor only serious edits to also issue for the provider to help the provider with Worksheet E part A. (D#001-00-005483)



Edits - Modified edit 60200S and downgraded it to a Serious error, rather than Level 1 and HCRIS consistency. Edit 60200S edits the contractor number (S-2 part I, line 141, column 3) against the known contractor jurisdictions. (D#001-00-005501 & 5502)

Edits - Corrected HFS Warning edit #802 for negative values in column 7 of Worksheet A. Only line 200 cannot be negative. (D#001-00-005518)

Edits - Revised CMS Edits 10300E, 10350E, 10400E, 10650E, 10700E and 10750E in accordance with CMS clarification. (D001-00-005531)

Edits - We added an HFS Serious edit #804, for FY overlapping 10/1/2012, and MDH. If S-2 part I line 20 FY, columns 1 and 2, straddle 10/1/2012, AND it is MDH (S-2 line 37 is NOT = 0), then we issue this error message: "Medicare MDH status ceased as of 10/1/2012. Ensure charges and payments are split accordingly." (D#001-00-005536)

Management Reports - Added report #182 - H-3, Part I Title XVIII Charges % to Total. (D#001-00-005056)

Management Reports - Modified report #181 - H-3, Part I Medicare Utilization CY/PY, so that now report is displayed with three tabs, instead of three pages. (D001-00-005057)

Move/Change/Combine - Corrected moving of data in Worksheet S-3 part I, in the Move/Change/Combine tool. (D#001-00-005492)

Printouts - we corrected a problem where the last digit of the provider number was truncated in the heading of W/S S. Some users had a different font for the PDF, and we now account for this difference. (D#001-00-005582)

Screens/Worksheets - Worksheet D-4 screens revised to reference footnotes at the bottom of the screen for the Worksheet references. (D001-00-005461)

Screens/Calculate - CMS has issued CR 7898 making a retroactive change to no longer take into account Section 1109 Payments in the Rural, 410A Demo calculation so we will need to shade our W/S E Pt H line 16 and delete any amounts that we find in this line on reports already produced. Hospital, 2552-96, version 25.29.131.0:

Auditor: Corrected a printing error that occurred when printing the Adjustment Report with a cover page and page numbers. (D#001-00-005551)

PS&R: Corrected the importing of reports 12A and 14A (we are now excluding these on import). (D#001-00-000861)

SNF, 2540-10, version 3.18.131.0:



Auditor - Corrected the freezing of printing the Auditor Adjustment Report when the combination of the cover page and the page numbers included options were used. (D#001-00-005494)

Calculate - Added improved checking of the cost center codes for A&G cost centers. (D#001-00-005457)

Calculate - Corrected saving of data for Worksheet D-1 line 12. We were not saving with the correct precision which caused an invalid record to be written to the ECR file. (D#001-00-005521)

CMS Instructions - Updated the CMS Instructions for S-3, II, line 11 to read "Enter the amount from Worksheet A, column 1, lines 14, 72, 74, 84, and lines 90 through 95." (D#001-00-005511)

Data Entry - If an A-6 reclassification is "out-of-balance", then the "out-of-balance" total column header will be displayed in red. (D#001-00-005499)

Edit - Removed Serious Edits #803 and #806 relating to D-1. Title XVIII does not use D-1 anymore (N/A for PPS), so these errors for line 6 and line 1 are moot. (D#001-00-005453)

Print - We corrected an issue where the last digit\character was being lost on worksheet S if printed to a pdf. (D#001-00-005566)

SNF, 2540-96, version 18.26.131.0:

Auditor: Corrected a printing error that occurred when printing the Adjustment Report with a cover page and page numbers. (D#001-00-005560)

ESRD, 265-11, version 1.21.131.0:

Auditor - Fixed problem that occurred in Auditor when printing the Adjustment Report with certain options selected. The program was locking up during the print routine. (D001-00-005495)

Printing - Corrected problem where slanted lines were printing on Worksheet S after ECR file was exported. (D001-00-005534)

Printing - Some computer have irregular PDF fonts that are wider than typical PDF fonts. We changed the reports to accommodate these wider fonts. (D001-00-005583)

Screens/Data Entry - Worksheet A-1 totals now turn red if not in balance for each reclassification. (D#001-00-005500)
